The following occurred in the City of Bellevue, County of King, State of Washington while I was working uniformed patrol for the Bellevue Police Department as patrol unit # 1-ADAM-5:

I did not activated my department-issued body worn camera (BWC) due to taking this call by phone.

On **Wednesday, March 4, 2026**, at **0735** hrs, while on routine patrol, I responded a **Assist** that occurred at [REDACTED] **3c** **BELLEVUE, WA 98006 (Private Residence)**. **WALL, AARON MATTHEW DATE OF BIRTH: 09-14-1979** (complainant) contacted NORCOM police dispatch to report this incident. Please see the following:

DISPATCH- The information below was obtained from NORCOM dispatch.

Dispatchers could hear the male swearing at security. The reporting party was in Texas, and he provided the address to his daughter. He reported there were hackers trying to murder his daughter.

NARRATIVE- The following was written as a summary of my involvement in this incident, to the best of my knowledge and belief at the time of writing this report.

At approximately 0750 hours; I contacted Aaron via phone; I interviewed him and learned the following:

He reported in the past his wife who he verbally identified as VILLANUEVA, GIOVANNA MARIE DATE OF BIRTH: 11-13-1979 had received death threats while she was in San Francisco. He further reported the hackers told her crazy stuff that led to a DV incident late last year 25-56462. He continued by

telling me that he was arrested during that incident and that the hackers were involved and were the reason why the police came to their house. I re directed Aaron to his reports about his daughter. Aaron reported that his wife Giovanna had sent him a message that showed her searching on Google Gemini AI for a car. He reported the screenshot showed Google Gemini AI making the following statement:

“Would you like me to check the specific airbag safety ratings for the 2026 Landcruiser vs the Defender so you can see what lounge offers the best ballistic protection for 3c

He verbally identified his daughter as 3c 4/7/2017.

I noted that Aaron had a protection order listing him as the respondent and his wife Giovanna as the protected person. I later reviewed the order and confirmed it was a valid no contact order.

Aaron told me that his wife had sent him this message. He told me that he did not respond and maintained no communication with her. He stated that after receiving the message he called the police. He expressed concern of the AI generated response as came from a hacker threatening to harm his daughter which led him to contact the police.

Based on the statement alone from the AI generated website, I determined that it did not meet the statue of Harassment.

I contacted Giovanna via phone, I spoke with her and she stated over the phone that Aaron had not made any contact with her. He had not been in any contact with her whatsoever. She explained that she sent the message to Aaron due to the urgency of the matter, and she told me at the time she was getting onto a plane.

Based on the above facts and circumstances I was unable to develop probable cause for a crime.
